ICAPGen recommends that you contact more than one *Accredited Genealogist* professional to learn about their rates, time commitments, and reporting procedures.

When writing an *Accredited Genealogist* professional, include:

1. A copy of your pedigree chart.
2. Details on those lines that need work.
3. Details on research that has already been done on those lines that need work. (Send only copies of your documents. Do not send originals.)
4. A self-addressed, stamped return envelope, or one with international reply coupon(s) if you do not live in the same country as the genealogist.
